Only charter members may serve on the Board of Directors, elect representatives to the Board of Directors, and exercise other rights and responsibilities as determined by the Association. All new members will need to be approved by the Board of Directors.

Charter Members

Charter Members (voting members) must be an executive officer of an energy related organization primarily located or doing business within New York State. An energy related business is defined as a business enterprise that is devoted to research, education, distribution, or application of technological innovation in the power generation, distribution, or end use field. If said business fails to meet these requirements during membership, then said membership shall be reviewed by the Board for approval of continued membership.

Associate Members

Associate Members (non-voting members) shall be allowed to attend general meetings and provide input to the Board on all appropriate issues. Associate members shall not be eligible for election to the Board of Directors of the Consortium, but are encouraged to serve on committees of the Consortium.



Partner Members

Partner Members (non-voting members based outside New York State) shall be allowed to attend general meetings and provide input to the Board on all appropriate issues. Partner members shall not be eligible for election to the Board of Directors of the Consortium, but are encouraged to serve on committees of the Consortium.
